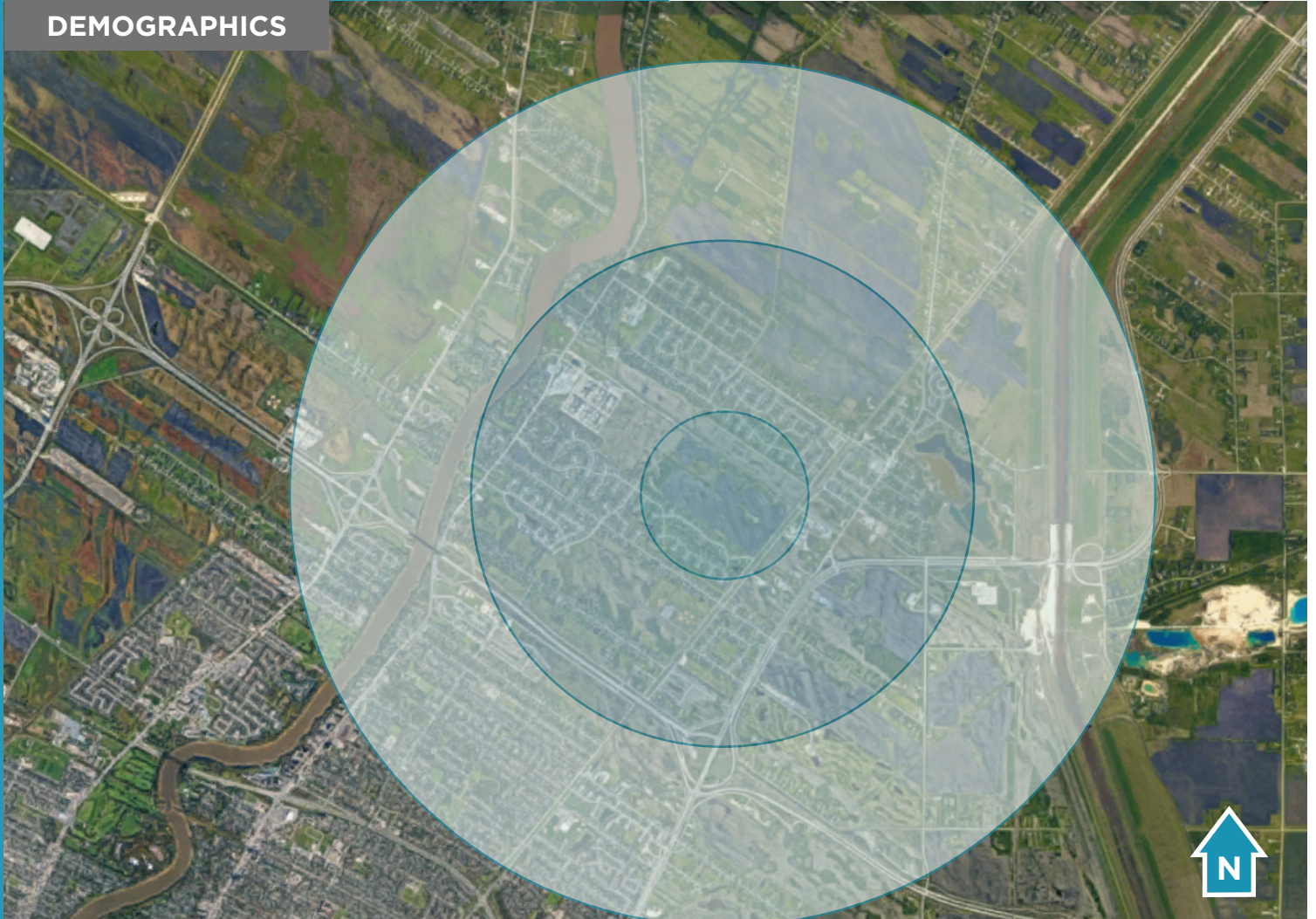
SITE PLAN

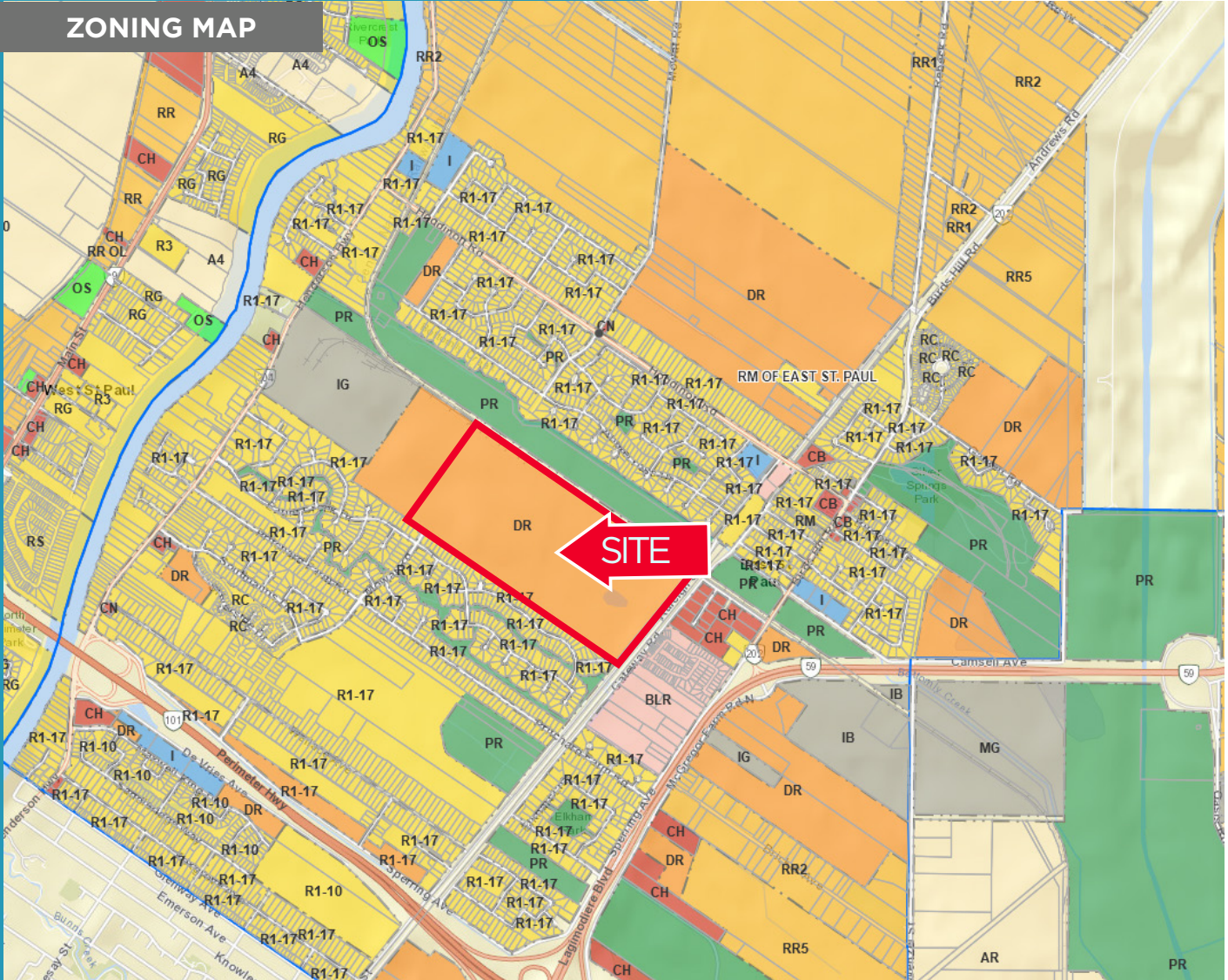
