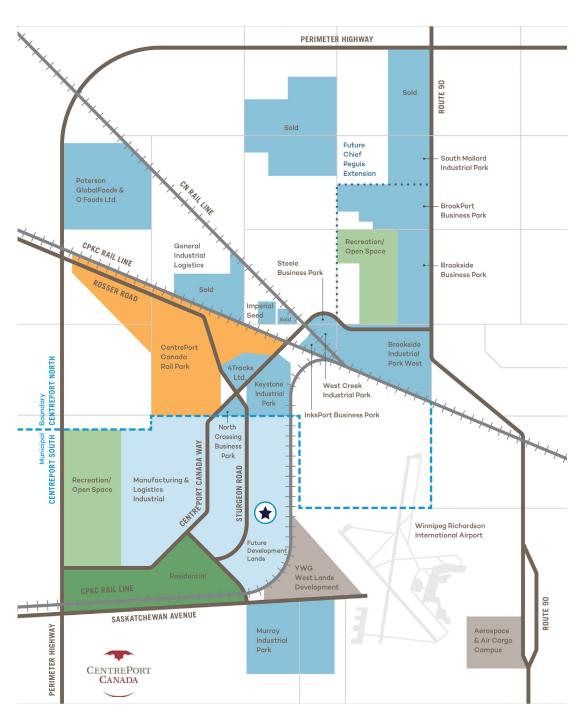

AREA MAP

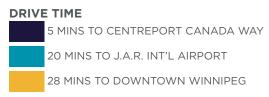

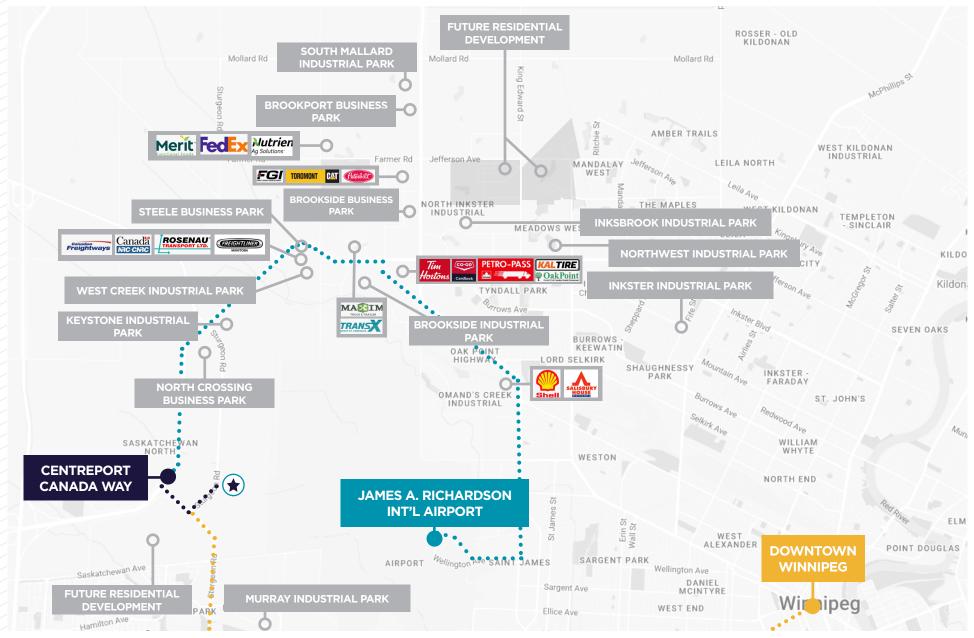
